General Summary

Washington State Community Connectors is a family run organization serving families using behavioral health services. We provide community, training, and leadership development. This position will be responsible for coordinating activities across our different programs including managing our volunteers. We currently hold multiple contracts with our state to provide family trainings including the SUD Family Navigator Training and the certified Peer Counselor training.

Primary Responsibilities

- Coordinate and schedule events and trainings including setting up registration, organizing reports and sending out invites.
- Present our WSCC Parent training series.
- Filling in as a backup trainer as needed for SUD Family Navigator and other trainings as needed.
- Coordinate our workgroups and committees program including tracking volunteers and overseeing all required documentation.
- Assist in other duties as requested related to project deliverables

Required Qualifications

- Hight School Diploma or GED
- Must identify as a parent or caregiver of a youth or young adult who has accessed behavioral health services in the last 10 years and has experienced supporting them to navigate those services.
- Must have experience working or volunteering as a family or parent partner.
- Must have great organizational, documenting, communication, and program development skills.
- Ability to be an active listener by asking questions and reflecting on what is being said.
- Proficient level of ability with computer software: Microsoft Office Products, Zoom and Gsuite
- Ability to work both independently and under supervision.
- Ability to maintain healthy boundaries with peers.
- Ability to manage time effectively.

- Established relationships with local community-based organizations.
- Previous experience working as a Certified Peer Counselor (CPC)
