- III. Have appropriate agency leadership sign the Commitment for Training and Fidelity Cadre Membership, ensuring you have adequate support in completing training and participating in future fidelity reviews as a review team member or leader as appropriate
- IV. Write a brief cover letter addressing why you are passionate about PSH, and why you are interested in establishing yourself as a leader and fidelity expert among your peers and leading reviews across your region
