# Ag Ed End of Year Report Data 2022

- 358 Ag Teachers filled out the 2021-2022 Ag Ed End of Year Report
- 71% of Ag. Teachers filled out the survey by End of August
- Of those teachers surveyed:
   223 or 62% Have a full-time assignment in Ag Ed
   135 or 38% Have less than full-time assignment in Ag Ed
- Teacher Full-Time Equivalent (FTE) ranges from .1 to 1.2 with average of .90 FTE.
   4 Teachers are Super FTE meaning more than 1 FTE
- **Extended learning days** range from 0 to 50 with an average of 16.06 down from 16.32 days last year and **127** teachers received no extended days.
- Extended days required exclusively during the summer range from 0 to 26 averaging 1.65 days per teacher up from 1.39 days last year.
- 35% of teachers received an FFA/Equivalent leadership stipend up from 31.6% last year.
- Student enrollment of Agriculture Education is down 38,055 this year with only 71% of teachers reporting data. Compared to last year's 38,964 with 90.1% reporting data.
- **29,203** students participating in Supervised Agriculture Experiences (SAEs) Compared to 32,637 last year with less teachers reporting in 2022.
- **70%** of Agriculture Education students reported have SAE's compared to 83% last year.






- **371** FFA Advisors on record in **196** FFA Chapters

  courses.
- 487 Total Teachers Coded as Ag Ed and receiving CTE enhanced funding




