Our early learning demosites highlight the following inclusive practices: inclusive mission and vision, MTSS, the Pyramid Model, differentiated instruction, culturally responsive pedagogy, braided funding, family and community partnerships, flexible service delivery, coordination and collaboration, and how to support CTE students in a preschool setting.

#### **Equal Access to Child Care**

Across the country children with disabilities are thriving alongside their nondisabled peers in childcare centers that foster inclusion. A child with a disability must never be turned away from a child care center based on assumptions about the severity of the disability or how much assistance they may need. Inclusive programs fulfill the ADA's promise to ensure equal access to child care programs for all children.
