# Frequently Asked Question (FAQ)

**Question:** Do all school districts have to provide services to children ages 3–5 years old?

**Answer:** YES!

Early Childhood Special Education (ECSE) is a federally mandated program under Part B, Section 619 of the Individuals with Disabilities Education Act (IDEA). It ensures that children ages 3 through 5 who have developmental delays or disabilities receive a Free Appropriate Public Education (FAPE) in the Least Restrictive Environment (LRE). ECSE services include specially designed instruction and related services tailored to support each child's unique developmental needs—such as communication, motor, cognitive, social-emotional, and adaptive skills. These services are delivered through an Individualized Education Program (IEP) and are designed to support school readiness and participation in inclusive early learning settings.

In Washington State, children become eligible for ECSE under IDEA Part B beginning on their **third birthday**, and school districts must ensure that an IEP is in place by that date—even if it falls during the summer. Under the Washington Administrative Code (WAC 392-172A-02000 & 392-172A-02055), districts are required to provide a **full continuum of placement options**, from inclusive preschool classrooms with typically developing peers to home-based or specialized settings, based on each child's needs.

Referrals for special education evaluations can be made at any time by families, caregivers, medical professionals, early learning providers, or others with developmental concerns. Children can be referred for evaluation and found eligible for ECSE services at any point between the ages of 3 and 5. For children transitioning from early intervention services (IDEA Part C), school

districts must ensure that an IEP is in place and services begin no later than the child's third birthday. For children newly referred and eligible after turning 3, services must begin as soon as possible following the development of an IEP. School districts are responsible for conducting timely evaluations and ensuring that all eligible children have access to appropriate ECSE services without delay.
