Identification and Correction of Non-Compliance for 2024–25

Local Education Agencies (LEAs) with non-compliance identified by OSPI during the 2024–25 school year were notified via email on September 19, 2025. Non-compliance identified through OSPI special education monitoring activities, LEA data submissions (including the new Secondary Transition IEP Components Report), due process decisions, and the State Performance Plan (SPP) compliance indicators during 2024–25 is included in the "IDEA Correction of Non-Compliance Workbook" (attached to the notification email). The identified non-compliance is required to be corrected by the LEA as soon as possible, but no later than March 2, 2026 (see, WAC 392-172A-07010(3)).

LEAs must complete their sections of the Workbook and upload to the 2025–26 IDEA Correction of Non-Compliance application (Form Package 442) in the Education Grants Management System (EGMS). The Form Package 442 can be found in EGMS by going to the "Monitoring" section (in the top menu) and then "Special Education Program Review" (in the Activities section of the left-hand menu).

If the LEA does not complete the identified corrections within the required time period, it may result in a delay in the receipt of federal IDEA funding available to the LEA for the 2026–27 school year and **will impact the LEA's 2025–26 Determination Level** (see, <u>WAC 392-172A-07012</u>).
