DVR 2024–2027 State Plan Public Forum Invitation

January 21, 2026 | 10–11:30am | Virtual

Department of Social and Health Services Division of Vocational Rehabilitation is preparing its State Plan progress update for 2024–2027, the planning document that describes the agency's goals, priorities, partnerships and activities to help individuals with disabilities achieve their employment goals.

WA-AIM Testing Information

WA-AIM testing will begin on January 26, 2025. Student records in DRC INSIGHT will be visible when the test window opens. However, user records in DRC INSIGHT are visible and can be added or removed at any time. January is a good time to ensure that all of your Test Administrators have access to the correct schools in your district. If you have individuals outside your district who will be testing students, now is the time to contact OSPI at wa.aim@k12.wa.us to ensure those users have access to the students they will be testing. In these requests, include the person's name and email address as well as the schools in your district that they will need access to for testing.

If you have not already completed a district-level training session for your test administrators, January is a great time to review the online video trainings together, answer questions, and communicate timelines and expectations for the testing window.

In addition, ESD 113 will be offering WA-AIM Open Office Hours starting in January. Each month will have a focus on the activities teachers will be working on that month. Office hours are available for staff from all regions throughout the state.
