New DCI Office

The Brookfield DCI office provided us the opportunity to rethink and redesign the DCI location architecture and come up with a standard to which all other DCI offices and to a certain degree, all remote sites, will follow. We are removing the need for routers at the network edge and are replacing them with multifunctional security devices which will better protect our information and resources. With the Fortigate firewalls, we were able to implement software-defined wide-access-network or SDWAN. SDWAN allows the DOJ to leverage both primary and standby circuits simultaneously, increasing the available bandwidth into and out of each site. It allows us to steer traffic based on application or use-case across either the faster, more-secure fiber path or slightly slower, less secure internet connection where available. Utilizing this technology, we can improve performance and security while lowering the complexity and cost of supporting and maintaining the network infrastructure in that office.

Up and Coming

There is a new look coming to the DOJ website. The redesign team is comprised of people across the department who have been diligently working on the new website to:

1. Make it easier for people to use and locate information
2. Improve security and features by keeping the software behind the website current
