Wisconsin Drug Endangered Children (DEC) Academy 101

DEC Academy 101 provides foundational knowledge around how drug endangered children are affected every day and everyone's role in identifying and helping them.

8:30-9:30am • Continental Breakfast (provided)

9:45-11:45am • DEC Awareness Training

The DEC Awareness Training helps participants gain awareness about drug endangered children, the risks they face, and the long-term impacts; understand the many opportunities to identify children at risk; and learn the importance of early identification and intervention to change the trajectories of the lives of drug endangered children and break multigenerational cycles.

Noon-1pm • Lunch (provided)

1-3pm • DEC Approach Training

This training focuses on how to implement the DEC Approach, which is a strategy based on a common vision, ongoing collaboration between various disciplines and agencies, and ongoing changes in practice. The DEC Approach is effective in improving the likelihood of better outcomes for drug endangered children.

3-5pm • Marijuana: The Danger Remains

This session outlines the risks children face whether marijuana is legal or not. The legalization of marijuana has only served to obscure these risks and, in some ways, elevate them. We will discuss immediate risks to children growing up in households where marijuana and marijuana products are consumed, grown, processed, and illegally sold.

10am-Noon • Intersection of DEC & Human Trafficking Training During this introductory training, participants will learn and understand the connections between drug endangered children and human trafficking, which are often overlooked by many disciplines. Definitions, statistics, and case examples will be shared to help participants recognize the vulnerabilities and understand the intersections as well as what can be done to identify and intervene. *Following this session, the training agenda will conclude for non-Walworth County attendees.*
