- Michael Allan was in his early 20s when he and a friend broke into someone's shed and stole various items. Now, two decades later, Allan has had successful employment as a driver and is a proud homeowner. The Court supports his pardon.
- Richard Balck was in his early 30s when he eluded an officer while under the influence. Now, over two and a half decades later, Balck is a certified crane and forklift operator and has maintained steady employment with the same company since 1995.
- Brian Bargenquast was in his early 20s when he sold a controlled substance to an undercover officer. Now, over three decades later, Bargenquast has earned forklift certification and a commercial driver's license (CDL). The district attorney's office also supports his pardon.
- Dustin Bartsch was in his late teens when he stole equipment from a high school. Two decades later, he completed special work certifications from the Institute of Packaging Professionals and volunteers for outdoor cleanup.
- Robert Batzler was in his late 40s when he was found in possession of marijuana in his home. Over 20 years later, Batzler has maintained steady employment as a carpenter.
- Cameron Beeney was in his late teens when he and a friend broke into a business and stole cash, checks, and credit card receipts. He was in his early 20s when he stole from a store and was caught with marijuana in his possession. Nearly a decade later, Beeney now resides with family and has received four certificates in welding.
- Anthony Cervantes was in his early 20s when he was found in possession of marijuana. Over a decade later, Cervantes has maintained steady employment as a taxi and limo driver since 2005.
- Daniesha Coleman was in her early 20s when she was found in possession of marijuana and a controlled substance. Coleman has moved out of the state and obtained a master's degree. She is employed as a business manager.
- Amanda Conners was in her late teens and a mother of two trying to support her children when she sold a controlled substance to a confidential informant. Two decades later, Conners pursued further education and volunteers in her community, where she resides with her family.
- Harold Coots was in his early 20s when he and others entered a garage and stole personal items from the owner. Dedicated to furthering his education, Coots obtained an associate degree in business-to-business marketing, completed three years of college coursework, and is currently enrolled at a Technical College for HVAC.
- Jennifer Crawford was in her late teens when she sold a controlled substance to an undercover officer. Three decades later, Crawford obtained both a certified nursing assistant (CNA) and a community-based residential facilities (CBRF) certification.
- Brandon Davison was in his late teens when he sold a controlled substance to an undercover officer. Over the past two decades, Davison has earned a technical diploma in

computer numeric control and completed training at the Professional CDL Training Institute.

- John Demers was in his mid-20s when he sold a controlled substance to an undercover officer. Over the past three decades, Demers has completed a mason apprenticeship and started a family.
- Kristopher Depner was a teenager when he sold marijuana to a confidential informant on three separate occasions, over 20 years ago. Now, Depner resides with his family and has maintained employment as an installer.
- Santana Dillon was in her late teens and trying to support herself and her child when she attempted to cash a fraudulent check. Now over a decade later, Dillion earned her master's degree in education and maintained successful employment as a middle school teacher.
- Casey Duffy was in her late 20s when she was found with marijuana in her residence. Over a decade later, Duffy has shown personal growth and positive adjustment. The district attorney's office also supports her pardon.
- Teresa DuPree was in her 20s when she was found with a controlled substance in her residence. Three decades later, DuPree moved out of the state and lives with family. She has earned a master's degree in nursing. The Court and district attorney's office also supports her pardon.
- Lee Econom was in his early 20s when he sold marijuana to an undercover officer. Almost two decades later, Econom has obtained an associate degree and volunteers in his community.
- Natalie Erickson was in her late teens when she sold a controlled substance to an undercover officer. Over a decade later, Erickson has earned an MBA and bachelor's degree in accounting and volunteers at a variety of community organizations including women's shelters, food pantries, and bible school.
- Nicholas Ernst was in his 20s when he was found in possession of a controlled substance and other drug paraphernalia. Almost two decades later, Ernst earned his GED and completed various training courses for welding, plumbing, and OSHA safety.
- Dennis Falck was in his mid-50s when he was found participating in a marijuanagrowing operation. In the past 20 years, Falck has become an active volunteer in his church and Quaker community and has served as the convener of the Land Compliance Committee and the Communications Committee.
- Jamie Farr was in his mid-20s when he was found in possession of marijuana and other drug paraphernalia. Now in his late 50s, Farr has maintained steady employment as a welder since 1995.
- Brandon Fickbohm was in his late teens when he and others stole cash and various items from several bars. Now over a decade later, Fickbohm received his technical diploma and is now enrolled in a registered nursing program.
- Brock Folts was in his early 20s when he was found with marijuana in his residence. Over a decade later, Folts resides with his family.

- James Freson was in his late 30s when he was found in possession of marijuana and controlled substances. Now, three decades later, Freson is retired after maintaining steady employment at the same company for nearly 40 years.
- Raul Garcia Jr. was in his late teens when he was found in possession of marijuana. Almost a decade later, Garcia has maintained steady employment and is a dedicated father and husband.
- Brian Gehler was in his early 20s when police attempted to pull him over for erratic driving but continued to speed away. Now, Gehler is a business owner and received substantial support for a pardon.
- Juan Guadalupe was in his late teens when he was found in possession of marijuana. Nearly two decades later, Guadalupe earned a variety of professional certifications and has worked for a trucking company.

- Lois Hachtel was in her late 30s when she failed to report her income while receiving state assistance. Now two and a half decades later, Hachtel has maintained employment in juvenile corrections for 17 years. The Court and district attorney's office also supports her pardon.
- Joshua Haus was in his late teens when marijuana was found in his residence. Now residing out of state, Haus has obtained a master's degree in interdisciplinary studies, became an ordained pastor, and is an active volunteer in his community. The Court supports his pardon.
- Christopher Henry was in his mid-30s when he was found in possession of marijuana. Now over two decades later, Henry has completed coursework toward a degree in forestry and volunteers with a local softball league.
- Charles Hermann was in his early 20s when he was found in possession of marijuana. Now, Hermann has started a family and maintained steady employment with UPS for over two decades.
- Laticia Jackson was in her mid-20s when she failed to report her income and in her early 30s when she was found in possession of a controlled substance. Now, two and a half decades later, Jackson has maintained steady employment as a caretaker after completing a variety of certifications.
- Tilwanna Jackson was in her early 20s when she used worthless checks. Almost two decades later, Jackson completed her GED, earned her cosmetology diploma, and received a certification as a nursing aid.

- Charsetta Jordan was in her early 30s and in an abusive relationship when she stole a friend's personal items and cashed fraudulent checks. Regarded as a mentor to youth, Jordan is active in her community serving on multiple community boards.

- Jessica King was in her early 20s when she assisted in the sale of a controlled substance. Now over two decades later, King fosters children, started a resource agency for at-risk pregnant women, and maintains employment at a counseling clinic.
- Gina Kluiber was in her late teens when she stole a checkbook on two occasions. Two decades later, Kluiber obtained an associate degree in medical assisting and now resides with family.
- Daniel Korderca was in his 20s when he sold a controlled substance to an undercover officer. Now retired, Korderca is a grandfather and maintained employment as an assembler for 45 years.
- Nicholas Kraemer was in his late teens when he and a friend stole propellers from boats. Now two decades later, Kraemer has maintained steady employment as a general laborer supervisor.
- Matthew Kramer was in his early 20s when he was found in possession of marijuana. Now three decades later, Kramer has completed a variety of certifications and has maintained steady employment with the same company for 14 years.
- Louis Krueger was in his mid-30s when he sold a controlled substance and recklessly endangered safety fleeing an officer. Now over three decades later, Krueger owns his own business after earning a technical degree in refrigeration services.

- Tina Peterson was in her early 20s when she sold a controlled substance to an undercover officer on two separate occasions. Now, Peterson has obtained an associate degree and maintained employment in the medical field since 2008.
- Tina Powers was in her mid-20s when she failed to report a household member's income while receiving public assistance. Over three decades later, Powers has owned and operated a secondhand store while raising four children with special needs as a single parent.
- Michelle Rangel was in his late 30s and having financial difficulties when she stole a woman's wallet. Rangle now resides with family.
