- Michelle Bozeman was in her early 20s when she wrote fraudulent checks. Now, nearly three decades later, Bozeman earned a bachelor's degree and is an active volunteer and leader in her community. The District Attorney's Office supports her pardon.
- Letdell Briggs was in his 20s when he failed to return a vehicle rented by another individual. Now, more than three decades later, Briggs has worked as a chaplain in hospital and hospice settings and is an active member of his community.
- Robert Davis was found in possession of marijuana. Over the last two decades, Davis has made positive adjustments and shown positive personal growth.
- Nathan Blazewicz was in his teens when he repeatedly drove a stolen vehicle and fled and resisted on one of those occasions. He was also in his teens when he drove another stolen vehicle. Now, more than two decades later, Blazewicz became a certified home inspector and coached youth basketball. The Court supports his pardon.
- Harry Canady was in his 20s when he sold a controlled substance to another individual who later sold it to a confidential informant. Now, more than three decades later, Canady obtained a commercial driver's license (CDL) and volunteers in his community.
- Kenneth Carter was in his late teens when he delivered a controlled substance, and later fled an officer was also found in possession of a controlled substance with intent to deliver, respectively. Now, more than two decades later, Carter became an ordained deacon and is an active volunteer within his community.
- Peter Dailey was in his 20s when he entered and took property from multiple residences. Now, decades later, Dailey obtained medical and firefighter licensure and volunteers teaching bicycle repair in his community.
- Quennetta Evans was in her 20s when she misappropriated bank account information to purchase services. Now, nearly two decades later, Evans earned both a technical diploma and an associate degree.
- Jason Familetti was in his teens when he and two other individuals caused property damage. Now, nearly three decades later, Familetti became a carpenter.
- Marcus Fenner was in his early 20s when he was found in possession of marijuana with intent to deliver. Now, two decades later, Fenner has shown personal growth and positive adjustment.
- Carolyn Foshee signed and cashed stolen withdrawal slips. Now, more than two decades later, Foshee is employed with a nonprofit organization and partners with a local humane society.
- Lonnie Grotjahn was in his late teens and early 20s when he entered and took property from multiple buildings. Now, nearly three decades later, Grotjahn has started two businesses, and the District Attorney's Office supports his pardon.
- James Hartley Jr. was in his late teens when he and two other individuals entered a residence and took property and when he drove a stolen vehicle. Now, more than three decades later, Hartley earned an associate degree in information technology. His pardon also received robust support from family, friends, and members of his community.
- Lisa Hessler was in her late teens when she signed and cashed a stolen check. Now, nearly three decades later, Hessler coached youth soccer and received recognition from the Federal Bureau of Investigation for assisting during an investigation.
- Brannon Holmes was in his late teens when he and other individuals caused property damage and stole marijuana. Now, more than two decades later, Holmes has partnered with a nonprofit organization on anti-violence initiatives.
- Dale Johnson was in his early 20s when he entered a residence and took property, then fled custody by foot. Now, more than four decades later, Johnson earned a GED and is a bowhunting mentor.

- Eldridge Johnson was in his late teens when he attempted to take a vehicle and took another and when he was found in possession of a firearm. Now, more than three decades later, Johnson earned a GED and volunteered during hurricane relief efforts. The District Attorney's Office supports his pardon.
- Pamela Kososki was in her late teens when she signed and cashed stolen checks. Now, three decades later, Kososki became a licensed acupuncturist and started a practice.
- Joshua Lutzke was in his early 20s when he was found in possession of marijuana. Now, nearly two decades later, Lutzke volunteers with city and county parks.
- Alisa Morgan cashed fraudulent checks. Now, more than two decades later, Morgan earned a GED and opened an Adult Family Home.
- Pamela Nyseth was in her late teens when she drove two other individuals to and from a burglary, and when she and another individual entered residences and vehicles, taking property. Now, more than three decades later, Nyseth furthered her career through additional training and also knits and crochets items to be donated. The Court and District Attorney's Office support her pardon.
- Vernaisa Sanders was in his early 20s when he used parts from a stolen vehicle. Now, nearly three decades later, Sanders is an active member of a men's support group and participates in an annual event promoting trades to students. The Court and the District Attorney's Office support his pardon.
- Jeffrey Smith fled a traffic stop and later used another individual's information to open credit accounts. Now, more than two decades later, Smith maintained employment with two police departments and volunteers with a cancer center. The District Attorney's Office supports his pardon.
- Keith Wooley Sr. was in his 20s when he attempted to take property. Now, more than five decades later, Wooley became a certified nursing assistant (CNA) and volunteers to give rides and deliver meals in his community.
- Darrin Baker was in his late teens when he and other individuals entered residences, taking property. Now, nearly two decades later, Baker was elected president of a community service club and received industry recognition as an emerging leader in his field.
- Ryan Barry was in his teens when he and other individuals used physical force to take money and caused property damage, and when he violated the terms of his bail by damaging property. Now, nearly two decades later, Barry served as the director of a food pantry and maintains employment.
- Ryan Dziejczak was in his teens when he entered a building and took controlled substances. Now, more than two decades later, Dziejczak has volunteered to support law enforcement safety initiatives. The Court supports his pardon.
- Emily Gonzales was in her early 20s when she was found in possession of marijuana and violated the terms of her bail, and when she and other individuals took and cashed checks without permission. Now, more than a decade later, Gonzales earned an associate degree and maintains employment.
- Weege Hartfield was in her 20s when she and other individuals cashed and purchased items with stolen checks. Now, two decades later, Hartfield volunteers as a security guard and participates in neighborhood cleanups.
- Ryan Jacques was in his late teens when he was found in possession of marijuana and another controlled substance with intent to deliver, as well as identification documents issued under false names. Now, more than two decades later, Jacques earned a bachelor's degree and volunteered at a boxing club. The District Attorney's Office supports his pardon.
- Tyara Jones was in her late 20s when she purchased items with stolen checks. Now, more than two decades later, Jones earned a High School Equivalency Diploma (HSED) and is an active volunteer within her community.
- Nathaniel Kingsby was in his early 20s when he drove another individual to and from a robbery. Now, more than three decades later, Kingsby has shown personal growth and positive adjustment.

- Wesley Kuehl was in his late teens when he and other individuals entered buildings and took and damaged property, including a vehicle. Now, more than five decades later, Kuehl led an afterschool program for elementary students and volunteers at a correctional facility.
- Matthew Lantta was in his late teens when he and other individuals participated in an armed robbery involving physical force. Now, nearly three decades later, Lantta earned his law degree and became a public defender.
- Ashley O'Neill was in her early 20s when she and other individuals staged a robbery to take money from her employer. Now, nearly two decades later, O'Neill earned an associate degree and volunteers with animal shelters and rescue organizations. Her pardon received support from a victim, who attests to her moral character.
- Orlando Quezare II was in his 20s when he was found in possession of a controlled substance with intent to deliver and was later found in possession of a firearm and a controlled substance with intent to deliver. Now, nearly two decades later, Quezare started a mentoring organization and volunteers speaking to youth.
- Niki Reed was in his late teens when he was found in possession of an illegal firearm. Now, more than three decades later, Reed became a licensed barber/cosmetologist and donates through his self-employment. The District Attorney's Office supports his pardon.
- Dwayne Roshell was in his late teens when he participated in a robbery. Now, three decades later, Roshell maintained employment as a driver and employs justice-involved individuals through his own business. The District Attorney's Office supports his pardon.
- Mary Sanford recklessly endangered safety and resisted an officer. Now, nearly two decades later, Sanford earned a master's degree in mental health counseling and became a licensed Substance Abuse Counselor in Training (SAC-IT) and Professional Counselor in Training (PC-IT).
- Perry Staples was in his late teens when he and other individuals entered residences, took items, and caused property damage. He was later found in possession of a firearm and a concealed weapon and operated a vehicle while intoxicated. Now, nearly two decades later, Staples leads Alcoholics Anonymous (AA) meetings at a local jail and serves as a member of his local county's drug court team. The Court and District Attorney's Office support his pardon.
- Gerald Strnad was in his early 20s when he and another individual trespassed. Now, two decades later, Strnad earned a GED, coaches youth sports, and is a member of a local auto racing team.
- Jason Wild Vasconcelos was in his late teens when he was found in possession of marijuana and drug paraphernalia, and he was in his 20s when he was found in possession of a firearm and marijuana. Now, more than two decades later, Vasconcelos became a certified wildland firefighter and started a business.
- Joshua Wojtyra was in his 20s when he participated in a robbery. Now, more than a decade later, Wojtyra has continued to operate his business. The Court supports his pardon.
- Lakesha Briggs was in her 20s when she was found in possession of a controlled substance with intent to deliver, and later, she was found in possession of marijuana with intent to deliver. Now, more than a decade later, Briggs maintained employment with a nonprofit organization and started a business.
- Thomas Browne delivered a controlled substance. Now, more than two decades later, Browne volunteered with an animal shelter and has shown personal growth.
- Tammy Bush sold a controlled substance to a confidential informant. Now, nearly two decades later, Bush became a certified tax preparer and started a business.
- Gwendolyn Cole was found in possession of and sold a controlled substance. Now, more than two decades later, Cole has maintained employment with nonprofit organizations and organizes donation drives.
- Yusuf Dahl was in his late teens when he was found in possession of a controlled substance and was found with intent to deliver. Now, more than two decades later, Dahl earned two master's degrees and has served on multiple nonprofit boards. The Court supports his pardon.

- Glen Golliday was in his late teens when he sold a controlled substance to an undercover officer. Now, two decades later, Golliday earned an HSED and started two businesses.
- Amber Hood was in her late teens when she was found in possession of marijuana and sold marijuana and a controlled substance to an undercover police detective. Now, more than two decades later, Hood became a personal care worker.
- Gerald Jones was in his 20s when he sold a controlled substance to an undercover officer. Now, three decades later, Jones volunteers with a ministry serving unhoused individuals.
- Matthew Jones was found growing marijuana. Now, more than a decade later, Jones has shown personal growth and positive adjustment.
- Samuel Koenen was in his late teens when he was found in possession of marijuana. A decade later, Koenen has now completed an apprenticeship and shown positive adjustment.
- Steven Pier was in his 20s when he was found growing marijuana. Now, more than two decades later, Pier completed an apprenticeship and became a business owner.
- Troy Reeves was in his 20s when he was found in possession of marijuana with intent to deliver. Now, nearly three decades later, Reeves has maintained state and municipal employment and coached youth sports in his community.
- Thomas Rosenfeldt was in his 20s when he sold marijuana to an undercover officer. Now, more than four decades later, Rosenfeldt completed an apprenticeship and is an active member of his community.
- Benjamin Aderman was in his late teens when he cashed and purchased items with stolen checks. Now, more than two decades later, Aderman earned a GED and became a volunteer fire engineer. The Court supports his pardon.
- Randall Bagley was in his late teens when he and other individuals entered a building and took property. Now, more than four decades later, Bagley pursued further education and donates landscaping services.
- Sherri Bond was in her 20s when she took property from a retail store and violated the terms of her bail. Now, more than three decades later, Bond has pursued further education in substance use disorder counseling and opened a transitional living center.
- Tarnesha Brown was in her 20s when she was found to be in possession of a firearm and was involved in a place in which prostitution occurred. Now, more than a decade later, Brown became a personal care worker and is pursuing a GED. The District Attorney's Office supports her pardon.
- Gregory Castillo was in his late teens when he drove a stolen vehicle, and he was in his early 20s when he was found in possession of marijuana and found with intent to deliver. Now, more than two decades later, Castillo earned an associate degree and leads a ministry at an elementary school. The District Attorney's Office supports his pardon.
- Angel Garcia was in his early 20s when he was found in possession of marijuana with intent to deliver. Now, more than a decade later, Garcia became a licensed real estate salesperson and coaches youth sports.
- Kenya Greene was in her 20s when she was found in possession of a controlled substance with intent to deliver and when she used a stolen credit card. Now, nearly two decades later, Greene pursued further education and volunteered at a high school. The Court supports her pardon.
- Nicholas Henke was in his late teens when he and another individual entered a business and took property. Now, more than two decades later, Henke completed employment-related certifications and has shown personal growth.
- Mario Hurt was in his late teens when he drove a stolen vehicle. Now, more than three decades later, Hurt started a business and donates videography services. The District Attorney's Office supports his pardon.
- Prentice Jones II was in his late teens when he fled from an officer. Now, nearly three decades later, Jones became a licensed barber/cosmetologist and earned an associate degree in film and video science. The District Attorney's Office supports his pardon.

- Quovana Jones was in her 20s when she was found in possession of a controlled substance with intent to deliver, and when she allowed another individual to take property from her employer. Now, more than two decades later, Jones earned a master's degree and co-founded a nonprofit organization. The District Attorney's Office supports her pardon.
- Randy Knueppel was in his 20s when he took and cashed checks without permission. Now, more than a decade later, Knueppel earned a bachelor's degree and has shown personal growth.
- Taylor Lang was in her early 20s when she entered a previous employer's building, taking money and causing property damage. Now, nearly a decade later, Lang earned a technical diploma in cosmetology and started a business.
- Steve Mai was in his late teens when he and other individuals entered parking garages and vehicles without permission, taking and damaging property. Now, more than two decades later, Mai started a business and participates in fundraising events. The District Attorney's Office supports his pardon.

Now, nearly two decades later, Prince is an active advocate, mentor, speaker, and volunteer. His pardon received robust support from leaders in his community who attest to his moral character.
- Christopher Reiter was in his early 20s when he was found in possession of marijuana with intent to deliver while armed. Now, more than three decades later, Reiter earned an HSED and became a carpenter. The District Attorney's Office supports his pardon.
- Michael Sylvester was in his late teens when he and other individuals entered buildings without permission, taking and damaging property. Now, more than three decades later, Sylvester completed employment-related certifications and donated services.
