# Proclamation

*WHEREAS*; observed annually on March 31, International Transgender Day of Visibility is a day to recognize the countless contributions that transgender and nonbinary people have made worldwide and to celebrate their strength, resilience, and perseverance in the face of adversity; and

*WHEREAS*; transgender and nonbinary individuals around the world have worked to overcome discrimination on the basis of gender, sex, race, sexuality, identity, class, and more for generations, combatting social stigma, demanding visibility, and working tirelessly toward equality and fairness for all people; and

*WHEREAS*; while significant strides have been made to ensure the rights and safety of transgender and nonbinary individuals, attacks against transgender and nonbinary individuals, as well as attacks against the entire LGBTQ community, continue to persist; and

*WHEREAS*; according to the Human Rights Campaign, at least 27 transgender and gender non-conforming individuals lost their lives to violence last year, and more than 2,400 hate crimes were recorded against LGBTQ individuals in 2024, with over 460 of those incidents being related to a victim's gender identity; and

*WHEREAS*; additionally, according to the American Civil Liberties Union, there have also been nearly 400 anti-LGBTQ bills introduced throughout the United States so far in 2026, including several bills in Wisconsin that target transgender individuals, specifically youth; and

*WHEREAS*; these staggering statistics further underscore the importance of combatting hateful rhetoric in all its forms, protecting transgender and nonbinary youth, and ensuring that all LGBTQ individuals are treated equitably and with dignity under the law and in their daily lives; and

*WHEREAS*; every day, transgender and nonbinary Wisconsinites lead by example, empowering individuals across the state, country, and world to embrace who they are, be true to themselves, live their most authentic and fulfilling lives, and hold hope for a brighter, more inclusive future; and

*WHEREAS*; while some progress has been made, there is still so much more work to be done to ensure that transgender and nonbinary Wisconsinites can stand boldly in their identity without fear of persecution, hate, violence, or discrimination; and

*WHEREAS*; today, the state of Wisconsin celebrates transgender and nonbinary Wisconsinites, recognizes diversity is an asset to our communities, and reaffirms the state's commitment to ensuring that Wisconsin is a safe, inclusive, and welcoming place for all those who call the state home;

*NOW, THEREFORE*, I, Tony Evers, Governor of the State of Wisconsin,  
do hereby proclaim March 31, 2026, as
