Institute of Fiscal Studies SEND report This new report states ' <i>Spending on special educational needs (SEND) is becoming unsustainable due to the rise in high needs. Reform to SEND funding and provision is needed.</i> ' The report highlights that the number of pupils with EHCP's has risen by 71% between 2018 & 2024 and notes that rises in ASD, ADHD and mental health needs appears to be a global issue across high-income countries.
